 7. Manuscripts submitted cannot have been previously published in any form or language. Authors should send manuscripts, including illustrations (JPEG, TIFF or BMP) at the best possible resolution, in electronic format (Word, OpenOffice). They should also enclose a short curriculum vita and a brief abstract of their paper in English and Spanish, and keywords in both languages. All references should appear in the text or in footnotes as follows: (author year: page(s)).

1. *ARQUEOLOGIA IBEROAMERICANA* is a peer-reviewed, open access international scientific journal, devoted to the archaeological study of prehistoric, protohistoric, ancient and historical societies of Latin America, the United States, the Iberian Peninsula, the Philippines and other Iberian countries.
2. It is published online four times a year in PDF electronic format and contains research articles on the archaeology of the American, Iberian and Filipino peoples.
3. Spanish, English and Portuguese are the primary languages.
4. Authors whose manuscript has been approved by the *Advisory Board* should pay a publication fee toward
